I agree that Ball State University shall own all intellectual property rights in and to all interviews, photographs, videotapes, DVDs, CDs, web pages and other media, recordings and materials relating to the Project, including but not limited to all copyrights therein. I assign and transfer to Ball State University my entire right, title and interest in and to all interviews, photographs, videotapes, DVDs, CDs, web pages and other media, recordings and materials created in connection with the Project, including all copyrights and other intellectual property rights therein. I further agree to promptly execute and deliver to Ball State University any and all documents submitted to me to further implement and make this assignment of rights effective.

I hereby release and forever discharge Ball State University, its trustees, officers, agents, employees, students and representatives from and against any and all actions or causes of action, claims, demands, or liabilities, for losses, damages, and/or expenses of whatsoever kind and nature, including attorney fees, which I have or may have for invasion of privacy, libel, defamation or any other cause of action arising out of or related to my participation in the Project and/or any of the products or materials created in connection with the Project. This Release shall be binding upon my heirs and assigns.
